AMENDMENT TO THE ARTICLES OF INCORPORATION OF BAY HARBOR CLUB OF BONITA BEACH CONDOMINIUM ASSOCIATION, INC.

EXHIBIT "A"

The Articles of Incorporation of BAY HARBOR CULB OF BONITA BEACH CONDOMINIUM ASSOCIATION, INC., shall be amended as shown below:

NOTE: New language is <u>underlined</u>; language being deleted is shown in struck-through type.

ARTICLE VI of the Articles of Incorporation shall be amended as follows:

ARTICLE VI.

The affairs of this corporation are to be managed initially by a Board of three-(3) seven (7) Directors who will be elected each year at the annual meeting of this corporation as provided for in the By-Laws, at such time as the Developer has relinquished control of this corporation as provided by the Condominium Act, the Board shall then be expanded to a maximum of nine (9) Directors, as follows: Four-(4) Three (3) Directors representing and being unit owners of each building and one (1) Director elected at large.
